Correct product specification for particular application is the responsibility of the purchaser.

The repair, replacement or prorated rebate of the full purchase price, chosen at the option of the manufacturer, constitutes the full liability of Bright Chair Company and is the sole remedy of the buyer. This warranty does not cover any costs for labor, removal, installation or freight of items covered by warranty. Bright Chair Company assumes no liability for commercial loss or consequential damages that may arise as a result of any product defect or fault. It is understood that these limitations of remedy and liability are part of the terms and conditions of purchase of Bright product and by placing an order, the buyer accepts these limitations.

Bright Chair Company uses, as standard, interior fill that meets California Bulletin 117 specifications. All furniture is manufactured with polyurethane foam products which, when ignited, will emit harmful fumes.

Bright products can be manufactured with interior fill that is in compliance with California Bulletin 133 interior fill specifications. To meet these specifications, Bright Chair Company uses coverings that have been tested to meet or exceed California Bulletin 117 compliance with a combination of fire retardant foam, dacron fiber and an interliner between the fabric and the foam.
